

# **General Guidelines for Submissions**

## of Blogs and Op-Eds

### **Blogs and Op-Eds Guidelines**

- A blog entry is very short (900-1200 words), condense, to-the-point analytical piece that address specific developments. Op-Eds are opinion pieces of short to medium length often written by opinion makers, political actors or NGO-affiliated members.
- Opinion should be stated clearly in the introduction. The contributions published reflect the personal opinions of the authors and do not necessarily correspond to the attitude of the Forum.
- References should be added as hyperlinks instead of citations (general citation rules are included below).
- A short biography must be provided alongside the piece.

### Format and Style

- All papers must be submitted in editable Word format.
- All pieces must have a main title.
- Please keep a consistent voice in the first or third person, keeping in mind that the third person is preferred.
- Acronyms should be spelled out in full the first time they are used followed by the acronym in parenthesis.
- Italicize non-English words, terms and terminologies, providing the English translations and necessary explanations in parenthesis.

- Use necessary chapter headings, avoiding using two subheads at the same time.
  Please check the sections below for more details.
- Make sure to leave space between paragraphs.
- Editable format for figures must be submitted in separate file.
- It is suggested that non-native English writers get their pieces checked by a person of native English fluency to avoid mistakes and facilitate the editorial process.

### Citation

- References must be prepared as Endnotes. Superscript numbers should be used inside the text to mark the references, and they should be placed at the end of sentences after the punctuation mark.
- Make sure to abide by the Chicago Citation style. Providing the links for the web references will not be enough, they will need to be properly cited following Chicago endnotes guidelines.
- Footnotes should be used for further notes and explanations. Please do not use footnotes for citation.
- In a blog or Op-Ed, hyperlinks are used instead of citations.

### **Figures and Pictures**

- All visual aids need to be clearly numbered.
- Captions need to be used if explanation is necessary.
- Pictures, graphs, data, etc. taken from other sources need to be cited.
- Editable version of graph and data figures must be submitted along with the text.
- Al Sharq Forum editorial team chooses the cover pictures for the pieces and does not need to discuss the cover with the authors but welcomes suggestions.

#### **Editorial Process**

- Al Sharq Forum adheres to high standards in providing accurate facts and information without bias and propaganda. As such, the editors might request changes, such as rewriting and/or reorganizing.
- After receiving the reviewed pieces, writers should comply with the deadlines in returning the piece to avoid delays in the publishing process. Major delays might even cause the piece to be rendered irrelevant in flow of current events. As such, the writers should be strict in their submissions back to the editors.
- Pieces may go through multiple reviews before publication.
- Al Sharq Forum gives no guarantee that the submissions will be published even if it goes through editorial process. The editorial team can reject papers at any stage of the publication process if the paper is seen short of qualifications for publication.
